Terms & Conditions and Technical Specifications for Supply, Delivery and Installation of ATM

- 1. Machhapuchchhre Bank Limited (MBL), Lazimpat, Kathmandu invites sealed proposal from the authorized distributors/suppliers for supply and delivery of computers and laptops required for the Bank.
- 2. Sealed proposal must be submitted to the General Administration & Procurement Department, Head Office, Lazimpat, Kathmandu before close of business hours on August 12, 2018. Proposal received after this deadline will not be accepted.
- 3. No consideration will be given to the proposal received after due date and time, even though dropped elsewhere or post office.
- 4. If the last date of submission and opening falls on a government holiday then the next working day shall be considered.
- 5. Suppliers should submit Company Profile, Copy of Firm/Company Registration, VAT Certificate & Tax Clearance Certificate for FY 2073/74 along with the sealed proposal.
- 6. The suppliers should be authorized distributor/suppliers of the supplied ATMs.
- 7. Payment will be done only after the supply, delivery, installation and final testing of the ATMs.
- 8. All Applicable taxes as per Nepal Government while paying the amount quoted in tender to supplier will be deducted at the source.
- 9. Bank will not pay any extra amount to supplier or other except the amount quoted in proposal.
- 10. The amount quoted must be valid for one year.
- 11. If the amount quoted in sealed proposal differs in words and figures, amount quoted in words will be considered valid.
- 12. The suppliers should submit the complete specification and brochure along with the proposal.

- 14. Warranty period of supplied ATM should be at least two years.
